

NOTICE OF PUBLIC HEARING(s)
COUNTY OF FORTY MILE No. 8 AND VILLAGE OF FOREMOST
IN THE PROVINCE OF ALBERTA

PURSUANT to sections 230, 606, 631 and 692 of the Municipal Government Act, Revised Statutes of Alberta 2000, Chapter M-26, as amended, the Council of County of Forty Mile No. 8 and the Council of the Village of Foremost in the Province of Alberta hereby gives notice of their intention to consider Bylaw No. 04/2020 and Bylaw No. 699/20, each being a bylaw to adopt the County of Forty Mile and Village of Foremost Intermunicipal Development Plan (IDP). The IDP is intended to foster on-going cooperation and coordination between the two municipalities and establish a framework for subdivision and development application referral requirements within the agreed to planning area. It also provides a means to address conflict resolution between the two municipalities, and provides a forum for discussing planning matters of joint planning interest within the planning area (lands adjacent to the Village of Foremost municipal boundary and those for approximately 3-miles within the County from the Village boundary).

THEREFORE, TAKE NOTICE THAT the Council of County of Forty Mile and the Council of Village of Foremost will be holding individual public hearings to consider adopting the proposed Intermunicipal Development Plan and the **public hearings** to contemplate the proposed bylaws will be held as follows:

AND FURTHER TAKE NOTICE THAT anyone wishing to make a written submission or oral presentation to the Village of Foremost Council regarding the proposed plan and adopting bylaw should, in writing, notify the Acting Municipal Administrator of the Village of Foremost no later than noon on November 16, 2020. Oral submissions may be limited to 5 minutes in length whether or not a written presentation is submitted to Village Council.

AND FURTHER TAKE NOTICE THAT anyone wishing to make a written submission or oral presentation to the County of Forty Mile Council regarding the proposed plan and adopting bylaw should, in writing, notify the Chief Administrative Officer of the County of Forty Mile no later than noon on November 24, 2020. Both written and/or verbal presentations may be given at the public hearings.

A copy of the proposed Intermunicipal Development Plan and bylaw may be inspected at the County of Forty Mile Administrative Building (303 Main Street, Foremost, AB) or the Village of Foremost Office (301 Main Street, Foremost, AB) during normal office hours.
